Sealed offers are invited from the registered manufacturer of LED glow sign board for providing and fixing a "LED signage" both in Odia and English with lettering "ବୟାନିକା, ହସ୍ତତତ୍ତ, ବୟନ ଓ ହସ୍ତଶିଳ୍ପ ବିଭାଗ, ଓଡ଼ିଶା ସରକାର" & "Boyanika, Handlooms, Textiles & Handicrafts Deptt., Govt. of Odisha" on the existing front ACP paneling of Boyanika showroom at Buxi Bazar, Cuttack. The interested parties are required to inspect the site prior to preparation of design and submission of offers. The scope of work includes fixing of above signage both in Odia & English. The offer should include technical bid and financial bid in separate covers containing in one sealed cover superscribed providing and fixing of LED signboard of Boyanika at Buxi Bazar, Cuttack.
