

EXPRESSION OF INTERESTS (EoIs)

Expression of interests (EoIs) is invited for engagement of Project Implementation Executive (PIE) in the project "Production of Handloom fabrics of Odisha on Natural Colours" Implemented by State Agency for Development of Handloom Clusters.

The PIE will be selected through a selection process after evaluation of his/her profile experience/knowledge in the relevant sector. The details of eligibility criteria, broad Terms of Reference (TOR) is as under. Retired Govt. employee, having experience in the rank of Inspector of Textiles with adequate knowledge, good track record and eligible as per Government guideline may apply for engagement into the post.

1. The head quarter of PIE will be fixed at Bhubaneswar.
2. The remuneration shall be of Rs.15,000/- per month.
3. The PIE will be responsible for day to day supervision of the project, maintenance of all relevant records, documentation and other work as may be entrusted as regards to the implementation of the project.
4. He/ She has to undertake tour within the project implementation area as and when required.
5. The engagement will be purely on contractual and temporary basis for a period of one year and will not be extended under any circumstances.
