Sealed offers are invited from Registered Architect, Interior Firms/Decorators/ Contractors for designing and renovation with interior and exterior work of proposed New Boyanka Showroom at the ground floor of hotel Lalita Mahal, Main Road, Jeypore (Koraput) on specified budgetary limit of Rs.20.00 (Twenty) Lakhs and specified time limit of one month. The scope of work includes renovation of existing shop room by dismantling of middle wall with insertion of beam, removal/shifting of existing sewerage/water line from the shop room, 3 phase line connection, air conditioning, provision of shelves for storage/display of handloom sarees/fabrics of minimum 1000 pcs., transparent sales counter/cash counter, wall paneling, false ceiling with electrical wiring, adequate light fittings, flooring, front facia with signage, development of frontage & backup system for power supply etc. as required for a cloth showroom.
