A. Fly Shuttle Frame Loom:-


- a) Reed space -56" (With 5 wheel Take Up Motion and Main Post - 4" X 3" Seasoned Sal Wood & Sley Seasoned Teak Wood)

B. Weaving Accessories:

1. Dobby with accessories:-
 - a) Lattice dobbie - 24 shaft.
 - b) Barrel dobbie: 7 shaft, 12 shaft, 24 shaft.
2. Charkha :-
 - a) Cycle rim charkha with spindle & break system.
 - b) High speed charkha with spindle & break system.
 - c) Motorized charkha with spindle.
3. C.V. heald of different brand & count (48^s x 52" to 96^s x 52").
4. Steel/brass reed of different brand & count (48^s x 52" to 96^s x 52").
5. Nylon Twine of different count.
6. Handloom bobbin: PVC/wooden (6 inch).
7. Handloom pirn: PVC/wooden (4 inch).
8. 4 spindle domestic bobbin winding machine with motor.
9. Horizontal Warping drum set of 4' diameter with bobbin & lease stand.

Term and Conditions-
